TOURNAMENT CONTRACT

GENERAL

The tournament contact is responsible for the actions of its participants and will indemnify and save harmless the Sundre Golf Club from all losses, damages, and claims whatsoever which the Sundre Golf Club suffers or incurs as a result of any act, neglect, or omission of the tournament participants.

The Sundre Golf Club shall not be held responsible for any loss or injury suffered or incurred by any tournament participant unless such loss or injury is caused by the negligence or wrongful act of the Sundre Golf Club or its employees.

The Sundre Golf Club reserves the right to alter starting times or format should the number of players differ greatly from the original booking.

PAYMENT

Bookings will be confirmed only by receipt of this agreement, once it has been read and signed by the group. A credit card is required at the time of booking to guarantee your date. \$1000 deposit will be charged to your credit card; full payment will be taken on the day of the tournament.

CANCELLATIONS

Cancellations must be made at least 2 weeks prior to the tournament date. Your deposit will be refunded within 60 days of the original booking. Your deposit will not be refunded if the entire tournament is canceled after 60 days of the original booking. Any cancellation within 2 weeks of the date of the event, will result in the group contact being held responsible for all player green fees and the credit card given will be charged for the amount of players booked.

DRESS CODE

All players must comply with the Sundre Golf Club dress code. Proper golf attire is required. Tailored, clean, denim pants are allowed. No short shorts, no halter tops or tube tops, no spaghetti straps, no sweat pants. Sundre Golf Club is a soft spike facility (no metal spikes).

ETIQUETTE

Proper golf etiquette is expected as a guest at the Sundre Golf Club. Repair ball marks, fix divots, rake sand traps, etc. All neighboring property to the course are off limits to the golfers. The Sundre Clubhouse is a smoke free environment. If smoking on the course, please ask the staff for a cart ash tray.

WEATHER

Your event will be considered on, unless Sundre Golf Club Management decides to close the course. Sundre Golf Club reserves the right to limit golf cart access to the course during inclement weather. Tournament start times may be delayed due to weather (frost, rain, lightning, snow) or other situations out of our control.

FOOD AND BEVERAGE

Finalization of the tournament menu must be made 2 weeks prior to tournament date.

It is the policy of the Sundre Golf Club to serve alcoholic beverages in a responsible and professional manner at all times. We adhere to all the laws and regulations as they pertain to the service of alcohol to under age and visibly intoxicated persons. Hours of service for alcoholic beverages are between 8 am and 12 am.

No outside alcohol may be brought to the Sundre Golf Club in compliance with the Alberta Liquor Laws, only alcohol purchased at the Sundre Golf Club may be consumed.

All food and beverage items must be purchased from the Sundre Golf Club.
